# Schedule and Commitments for Achieving Compliance with Each Requirement of Attachment 1 to the Orders

### **Order EA-04-185**

OPPD will complete implementation of all of the requirements in Attachment 1 to Order EA-04-185 before spent fuel is placed in the Independent Spent Fuel Storage Installation (ISFSI). Spent fuel is currently scheduled to be placed in the ISFSI on April 1, 2006. (AR 36282)

#### **Order EA-04-187**

OPPD will complete implementation of the same compensatory measures for access authorization as described in Reference 1 below for the ISFSI as provided for in additional security measure A.2 of Attachment 1 of Order EA-04-187. This will be completed no later than the first day that spent fuel is initially placed in the ISFSI. Spent fuel is currently scheduled to be placed in the ISFSI on April 1, 2006. (AR 36282)
