The staff finds that WCAP-16081-P is acceptable for referencing in licensing applications for boiling water reactors to the extent specified and under the limitations delineated in the TR and in the SE enclosed with the December 9, 2004 approval letter. Based on a conversation with your staff we are sending this revised cover letter to remove references to Westinghouse and Combustion Engineering pressurized-water reactors. The accepted versions of the TR should also incorporate this letter.
