Enclosure 4 includes copies of changes to the BFN Technical Specifications (TS) Bases in accordance with BFN TS Section 5.10, TS Bases Control Program for Units 1, 2, and 3. The changes have been incorporated for which prior NRC approval was not required.

Enclosure 5 contains Section 5.1, Technical Requirements (TRM) Control Program for Units 1, 2, and 3. The changes have been incorporated and did not require prior NRC approval.
