Enclosed is Amendment No. 97 to your NRC Material License No. 13-00133-02 in accordance with your request. Please note that the changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that the deletion of the Cordis Checkmate System and Novoste Corona Model A1730 device authorizations from your license has affected a number of other License Conditions and authorizations. These changes are shown in **bold** font.

Please be advised that I was unable to approve William K. Breeden, III, M.S. as an Alternate Radiation Safety Officer because 10 CFR 35.24(b) only permits the authorization of one Radiation Safety Officer for each license. If you have further questions concerning this matter please contact me at either (630) 829-9841 or (800) 522-3025.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

Please note that on October 25, 2004, the NRC suspended public access to ADAMS, and initiated an additional security review of publicly available documents to ensure that potentially sensitive information is removed from the ADAMS database accessible through the NRC's web site. Interested members of the public may obtain copies of the referenced documents for review and/or copying by contacting the Public Document Room pending resumption of public access to ADAMS.
