Enclosed is amendment No. 49 to U.S. Nuclear Regulatory Commission (NRC) License No. SNM-33, in accordance with your request transmitted by your letter from Ms. Karen Craig, Manager, Regulatory and Licensing, dated December 7, 2004. This amendment changes the ventilation requirements for work in building complexes at the Hematite facility. We have completed our review of the revisions to Chapter 3, Section 3.2.2, and have found it to be acceptable. Accordingly, License Condition 17 has been revised to include the December 7, 2004 revision of Chapter 3, and to read as follows:

"Except as specifically provided otherwise in this license, the licensee shall conduct its program in accordance with the statements, representations, and procedures contained in the documents, including any enclosures, listed below. The U.S. Nuclear Regulatory Commission's regulations shall govern unless the statements, representations, and procedures in the licensee's application and correspondence are more restrictive than the regulations.

- A. Application dated December 7, 2004 (Chapter 3 modified). Application dated April 21, 2004 (Chapter 2). Application dated October 29, 1993, (Chapters 1, and Chapters 3 through 8) and supplements dated November 24, 1993; January 14, January 28, March 21, April 20, June 14, and October 24, 1994; January 28, February 27, April 24, July 27, October 31, and December 15, 1995; January 26, May 29, and October 23, 1996; August 8, August 11, August 12, and December 8, 1997; July 10, 1998; January 15, March 12, June 3, August 13, and December 6, 1999; February 7, April 7, June 21, and December 22, 2000; and March 6, August 2, September 11, and October 24, 2001.
- B. Letters dated August 22, and 28, 2002, September 4, 2002, December 30, 2003, April 7, June 15, August 27, 2004, and December 7, 2004."

Enclosed are copies of the revised Materials License SNM-33 and the Safety Evaluation Report. We also have determined that this action qualifies for a categorical exclusion pursuant to 10 CFR 51.22(c)(11). The requested action is administrative in nature and is not a major federal action. As such, the preparation of an Environmental Assessment is not required.
