To Federal, State, and Provincial Regulators:

The NERC Board of Trustees has approved the Third Quarter 2004 Compliance Performance Report for public release. This is the first report issued under the new NERC Guidelines for Reporting and Disclosure, effective July 1, 2004. This marks the first time that NERC has publicly identified those entities confirmed to have violated NERC and regional compliance measures.

This as a significant step in NERC's commitment to transparency of the results of the NERC and regional reliability council compliance programs. Such transparency is vital if stakeholders, regulators, and the public are to have confidence that the electric industry is doing all that is necessary to ensure a reliable bulk electric system in North America.
