Judge Baratta and I request that at least one lawyer for each party be available tomorrow morning, 11/19, at 10:00 a.m. for a short informal telephone conference call, to discuss briefly our pending rulings on two matters - BREDL's appeal of the NRC Staff's recent need-to-know ruling, and BREDL's motion for interim discovery measures. Because our security expert, Mr. Young, is out of the office until Monday, we will not be able to issue our rulings until he is here to help us determine whether anything should not be released publicly, but we would like to provide as much information as possible to you tomorrow in consideration of the parties' schedules. In addition, we would like to know whether the Staff intends to file a response to BREDL's motion. We will therefore appreciate your availability tomorrow morning if at all possible.

If all parties cannot have someone available for a short call tomorrow, we will issue our rulings Monday after hearing from the Staff on BREDL's motion, and consultation with Mr. Young.
