In the licensee's application dated 7/14/2000, Item 7, they committed that the RSO responsibilities may be delegated to other individuals if needed. The letter dated 12/15/00 does commit the RSO to review all records, but states it will be done by telephone at least quarterly. I discussed with Mr. Port that the October 8, 2004 letter may be unnecsary, and sets up another level of commitment. Since the RSO can delegate, the October 8, 2004, letter really is not needed. He said he would discuss it with the RSO and get back to me.</p> <p>12/16/04 Mr. Port said that the RSO agrees that the October 8, 2004 letter requesting action is not needed, and would like to abandon the action.
