Dear Sir or Madam:

The Robert Wood Johnson Medical School (RWJMS) respectfully requests the addition of a new radioactive waste storage facility, located at 126 Davidson Road, Piscataway, NJ 08854, to our list of facilities authorized to use licensed materials.

This facility will primarily be utilized for the storage and handling of short lived solid radioactive wastes held for Decuy-In-Storage (DIS). In addition, we may temporarily store and/or handle other waste streams including, but not limited to, long-lived dry active waste, animal carcass waste and liquid scintillation vials. The non-DIS waste streams will be stored/handled prior to shipment off-site for ultimate disposal. This facility will not be utilized for the storage of RCRA hazardou; wastes.

This new facility consists of an enclosed 60-foot by 40-foot epoxy-coated concrete slab. A small "processing room" is included to facilitate the re-packaging of wastes following the DIS period. The building has a fire suppression system and security consists of a chain link fence that encloses the entire compound and the building itself has locked doors.

Lastly, the new facility falls into Zone C of community 340274 – panel 0003B of the Flood Insurance Rate Map issued by the National Flood Insurance Program. Zone C is an area of minimal flooding and requires no flood prevention measures.

We believe this new building will be a significant improvement to our program and afford safer and more secure waste handling and storage. During a recent NRC inspection of the Robert Wood Johnson Medical School's license of broad scope, Ms. Michelle Beardsley, Health Physicist, commented favorably regarding the new construction. Most of the activities that will be conducted in the new facility are currently taking place in the ESB Annex, an old greenhouse that is primarily constructed of glass and does not have a fire suppression system.
