Dear Mr. Luthiger:

Under letter dated June 24, 2004, Rio Algom Mining, LLC (Rio Algom) requested an amendment to Source Materials License, SUA-1473 to update License Condition 22 with a revised surety amount. In a response letter to Rio Algom dated July 28, 2004, the U.S. Nuclear Regulatory Commission (NRC) asked that Rio Algom provide supplemental and backup data for the annual surety update. The NRC has not yet received the requested information and, as a result, the NRC is closing the Technical Assignment Control Number (TAC LU0055) associated with the review of this action.

Rio Algom is required under the regulations in 10 CFR Part 40 to provide annual updates for financial assurance for the reclamation of mill sites licensed by the NRC. Therefore, within 10 days of the receipt of this letter, please respond with the additional information requested in our letter of July 28, 2004, or provide a date by which you will do so.
