**SUBJECT: SAFETY LIGHT CORPORATION, APPROVAL OF PLAN FOR THE ORDERLY SHUTDOWN OF LICENSED ACTIVITIES AND RELAXATION OF ORDER, CONTROL NOS. 134920 AND 134921**

Dear Mr. Lynch:

This is in reference to your letter dated December 20 in which you submitted, pursuant to an "Order Suspending License (Effective Immediately)," issued December 10, 2004, a plan for the orderly shutdown of licensed activities (Plan). Additional information was provided in letters dated December 27 and 28, 2004. In accordance with Section V of the Order, your Plan is hereby approved. From a period beginning on January 1, 2005 until March 31, 2005, all licensed activities shall be limited to those activities authorized under the Order and in accordance with the Plan.

Through the submission of your Plan you requested the relaxation of certain provisions of the Order, which is permissible in accordance with Section V for good cause shown. NRC clarified that you were requesting a relaxation and requested additional information in a letter dated December 22, 2004. You responded to this request with your letters dated December 27 and 28, 2004. Upon review of your letters dated December 20, 27 and 28, the NRC has determined that good cause for relaxation of the Order has been shown in that your Plan provides for the orderly termination of operational activities by the March 31, 2005 date provided in the Order and assures the safe handling of material returned to you by customers in the interim. Accordingly, in accordance with Section V of the Order, the NRC has determined good cause was shown and relaxes the Order as follows:

1. (Section V.B.1&2) Safety Light Corporation may continue to receive new light sources through January 31, 2005, in order to fulfill contractual obligations to customers, which include national defense contractors.
2. (Section V.B.4) Safety Light Corporation may continue to receive and process exit signs or other devices containing licensed materials, returned from its customers to the extent that Safety Light Corporation can transfer the tritium source tubes from those signs to an authorized recipient by March 31, 2005.
