EGC now revises its response to RAI 13.3-2, and includes herewith the requested copy of the state and local emergency plans (the "Plans").

The State of Illinois and the Illinois Emergency Management Agency consider the Plans to be exempt from public disclosure per section 7(ll) of the Illinois Freedom of Information Act [5 ILCS 140/7(ll)] since the public disclosure of this information could adversely impact government response capabilities. As such, the Plans (in their entirety) are requested to be withheld by the NRC from public disclosure pursuant to 10 CFR, Section 2.390(a)(3) as a document "specifically exempted from disclosure by statute."
