To Whom It May Concern:

We would like to amend our Materials License to reflect the following changes...

- Remove Jane R. Fisher, as the Radiation Safety Officer.
- Add Douglas E. Heim, B.S., as the Radiation Safety Officer. Mr. Heim has previous experience as a Radiation Safety Officer under NRC License 37-16554-01. Refer to the attached Delegation of Authority.

Mr. Heim is a consultant to many NRC and State licensed facilities in Pennsylvania. Mr. Heim provides consulting services to our facility. During his visits he spends the day at our facility conducting equipment evaluations, personnel exposure reviews, and various audits of our radiation safety practices and radioactive material use areas.

Mr. Heim will be delegated authority in all matters related to radiation safety. The RSO will be able to exercise authority over all authorized users relative to radiation safety issues. If a problem should arise in which patient care is involved, the RSO will consult with the authorized user to determine the appropriate actions to resolve the issue and to prevent a recurrence.

The administration of this facility will authorize and delegate authority to Mr. Heim to appropriate funds required to maintain our radiation safety program within the objectives of our program and related regulatory requirements.

As described above, the RSO will provide monthly visits to our facility. In the event of an emergency which requires his presence it would take a maximum of 3 hours for him to arrive at our facility. In addition, he is available by phone at any time to answer questions or respond to operational issues that may arise. Mr. Heim will be assisted by Samuel L. Payne, M.S., who is also an RSO on multiple NRC licenses.




### **Radiation Safety Officer - Delegation of Authority**

You, Douglas Heim, have been appointed Radiation Safety Officer and are responsible for ensuring the safe use of radiation. You are responsible for managing the radiation protection program; identifying radiation protection problems; initiating, recommending, or providing corrective actions; verifying implementation of corrective actions; stopping unsafe activities; and ensuring compliance with regulations. You are hereby delegated the authority necessary to meet those responsibilities, including prohibiting the use of byproduct material by employees who do not meet the necessary requirements and shutting down operations where justified by radiation safety. You are required to notify management if staff do not cooperate and do not address radiation safety issues. In addition, you are free to raise issues with the Nuclear Regulatory Commission at any time.
