CHAIRMAN DIAZ: Good afternoon. Madam Secretary, I understand you have some items for affirmation for us?

MS. VIETTI-COOK: Yes, the first item is Private Fuel Storage. Independent Spent Fuel Storage Installation. The Commission is being asked to act on a Memorandum and Order responding to Petitions for Review from Private Fuel Storage and the State of Utah. These Petitions challenge the Licensing Board's March 31, 2004 Order addressing issues of redaction of information from four previous Board orders and from the administrative record. The Petitions for Review also present similar arguments on the issue of what portions of CLI-04-10 should be redacted prior to that Order's release to the public. The Commission has voted to approve a Memorandum and Order which affirms in part and reverses in part the Board's March 31st Order and rules on the disclosure or redaction of various kinds of information in the record and in the Board's and Commission decisions. The Memorandum and Order further directs the Board and parties to follow specific procedures set forth in the Memorandum and Order regarding preparation of redacted versions of the Board's five orders dated January 5, 2004, March 31, 2004, and May 27, 2003, and likewise regarding preparation of redacted versions of this Memorandum and Order, CLI-04-10, and CLI-04-27. Would you please affirm your votes?
