

2. Calibration of dose calibrators, scintillation detectors and survey meters


3. Calculation, dispensing and calibration of patient doses, including proper use of radiation shields.

4. Following appropriate internal control procedures to prevent mislabeling or other errors.

5. Learning emergency spill procedures including containment, isolation, decontamination and evacuation. Also includes wipes and surveys.

6. Elution of Tc-99m generator systems, assay of the eluate for Tc-99m, Mo-99, qualitative tests for Al³⁺, processing of the eluate with reagent kits to compound Tc-99m radiolabeled radiopharmaceuticals and related testing of these pharmaceuticals.
