This refers to the financial assurance documents that you had submitted to this office to satisfy the requirements in 10CFR 30.35 for the above listed NRC licenses. The documents included two Irrevocable Letters of Credit each dated November 7, 1997, from PNC Bank, N.A., and a Standby Trust Agreement dated November 14, 1997. PNC Bank has amended each of the Irrevocable Letters of Credit since they were originally issued, the latest amendment to each is dated November 9, 2004.

A review of your financial assurance documents in our files indicated that we inadvertently returned to you one of the two original Letters of Credit with our correspondence dated January 25, 2001 (ML010250359). This Letter of Credit was for your facility in Whippany, New Jersey. Please return the original Letter of Credit to this office via certified mail so that you may remain in full compliance with the applicable regulatory requirements. We regret the inconvenience this may cause you, and appreciate your cooperation with us.

Please be reminded that the possession limits currently authorized on each of the above two NRC licenses require you to submit a decommissioning funding plan (DFP) as described in 10 CFR 30.35(e), for each license. The DFP must be submitted to NRC no later than December 2, 2005.
