(Hearing Request Referral)

By memorandum dated January 5, 2005, the Secretary of the Commission referred to the Licensing Board Panel a December 30, 2004 request by Safety Light Corporation (SLC) for a hearing regarding the December 10, 2004 action of the Director of the NRC Office of the Nuclear Materials Safety and Safeguards denying the April 22, 2004 SLC request to, among other things, renew its two byproduct materials licenses to manufacture devices containing tritium at its Bloomsburg, Pennsylvania facility. Because that request, filed in accordance with 10 C.F.R. § 2.103(b), falls within the jurisdiction of the Licensing Board previously established to conduct this proceeding regarding the April 2004 SLC license renewal/amendment request,

no additional Licensing Board constitution action is being taken relative to that hearing request referral.
