Appendix C of this NUREG should be helpful in identifying the information required by the NRC to process your request for license renewal. Appendix E of the NUREG shows a sample license application.

Please note that on October 25, 2004, the NRC suspended public access to ADAMS, and initiated an additional security review of publicly available documents to ensure that potentially sensitive information is removed from the ADAMS database accessible through the NRC's web site.
