Order (Approving Settlement and Dismissal of Contention EC 3.3.4)

On December 29, 2004, the Blue Ridge Environmental Defense League, the Nuclear Information and Resources Service, and Public Citizen, and Dominion Nuclear North Anna, LLC, with the NRC Staff's support and consent, moved for an order approving settlement and dismissal of Contention EC 3.3.4, "Failure to Provide Adequate Consideration of the No-Action Alternative." In accordance with 10 C.F.R. § 2.338(g), the Parties forwarded the settlement agreement and a proposed order.

Consistent with Commission policy to encourage resolution of contested issues in licensing proceedings through settlement, we find dismissal in the public interest. Pursuant to our authority under 10 C.F.R. § 2.338(i), we grant the motion and dismiss Contention EC 3.3.4.

Dismissal of this contention supersedes the obligation of the Board's Order of August 31, 2004, to preserve and maintain privileged documents specific to Contentions EC 3.3.4.
