Re:

French and Parrello Associates, P.A. (FPA) would like to renew our materials license. In June of 2003, Mr. Ryan J. Tumpey became the corporate RSO, and in the course of amending our license to reflect this change, it was suggested by Kathy Modes in the Region I office to update the format of our entire license to the current standard. In a letter dated June 9, 2003, the Region I office approved the information from NRC Form 313 that we had submitted and issued an amended license. The docket number for this action was 03031295 and the control number was 133159.

Since amending the license in June 2003, FPA has purchased two additional portable measuring devices, bringing our total to eight. The sealed source model numbers for both new devices are identical to the model numbers previously submitted on NRC Form 313 and our total quantities of Cesium 137 and Americium 241 are still under the maximums allowed by our license. No other changes have been made to our Radiation Safety Program.

We feel that our Radiation Safety Program meets or exceeds the current industry standards and is being properly implemented. Since the NRC Region I office has recently reviewed and approved our information provided on NRC Form 313 and it completes the requirements for renewal therein, we are requesting that the NRC renew our materials license based on this information.
