Dear Abhaya:

On the morning of March 2, 2005, the NRC staff will meet with a subcommittee of the Advisory Committee on Reactor Safeguards (ACRS) to discuss the recently issued draft safety evaluation report (DSER) for the North Anna early site permit application. (You should have received a copy of this document, as a CD was mailed to all persons on our distribution list for the North Anna ESP. If you did not receive your copy, please let me know.) ACRS meetings are open to the public, and any member of the public may request an opportunity to make an oral statement during such meetings. Most ACRS meetings (including this one) are held at the ACRS meeting room at 11545 Rockville Pike (NRC headquarters) in Rockville, MD.

The staff will also meet with the full ACRS on either March 3 or 4, exact date as yet unknown, again to discuss the DSER. While I will make a note to myself to contact you with the exact date when I learn it, I suggest you visit the ACRS web page at <http://www.nrc.gov/what-we-do/regulatory/advisory/acrs.html> a week or two before the event, as the ACRS posts its meeting agendas at that location. The ACRS web page also provides information on the role of the ACRS in NRC regulatory activities.
