SUMMARY

We have reviewed your notification letter dated October 12, 2004, requesting an amendment to your byproduct materials license and find that we need additional information as follows:

Dr. Trover submitted a copy of the Kentucky Agreement state license he was named to. However, I do not have familiarity with the Kentucky regulations and how they translate into NRC authorizations in 10 CFR Part 35, as Dr. Trover has requested.

Please provide sufficient information such that the authorizations Dr. Trover has requested are adequately supported by the Kentucky regulations and license he submitted.

Please note that on October 25, 2004, the NRC suspended public access to ADAMS, and initiated an additional security review of publicly available documents to ensure that potentially sensitive information is removed from the ADAMS database accessible through the NRC's web site. Interested members of the public may obtain copies of the referenced documents for review and/or copying by contacting the Public Document Room pending resumption of public access to ADAMS.


