The Nuclear Regulatory Commission is requesting emergency publication of the document entitled, "United States Nuclear Regulatory Commission Notice of Availability of Draft NUREG-1800, Revision 1, "Standard Review Plan for Review of License Renewal Applications for Nuclear Power Plants" and Draft NUREG-1801, Revision 1, "Generic Aging Lessons Learned (GALL) Report," which was transmitted on January 28, 2005, to the Office of the Federal Register for publication. We request that this document be published Tuesday, February 1, 2005. We are requesting emergency publication because of the need to issue these documents for public comment at the earliest possible date. These documents provide the bases for applicants' preparation of license renewal applications to operate their nuclear power plants for an additional 20 years. Continued operation of these plants has significant financial and energy sufficiency implications. Applicants have indicated that these documents will be used for license renewal applications that will be submitted this summer.
