SUBJECT: DIRECT FINAL RULE TO REVISE THE 10 CFR PART 72 LIST OF

APPROVED SPENT FUEL STORAGE CASKS (NUHOMS® -24PT4),

AMENDMENT NO. 1

Your concurrence is requested on the attached direct final rule and associated proposed rule that will revise the list of approved spent fuel storage casks (10 CFR 72.214). The staff is amending its regulations containing the list of approved spent fuel storage cask designs to add an amendment to the Transnuclear, Inc., Standardized Advanced NUHOMS® System.

The cask, when used in accordance with the conditions specified in the revised Certificate of Compliance (CoC) and the U.S. Nuclear Regulatory Commission (NRC) regulations, will meet the requirements of 10 CFR Part 72; thus, adequate protection of public health and safety would be ensured. The cask amendment will allow holders of nuclear power reactor operating licenses to store spent fuel in the cask under the revised conditions. Amendment No. 1 to the Standardized Advanced NUHOMS® System CoC adds another Dry Shielded Canister, designated NUHOMS® -24PT4, to the authorized contents of the Standardized Advanced NUHOMS® System. This canister is designed to accommodate 24 intact Pressurized Water Reactor fuel assemblies with or without integral burnable poison rods or integral fuel burnable absorber rods, or up to 12 damaged fuel assemblies in lieu of an equal number of intact assemblies. It is designed for use with the existing Advanced NUHOMS® Horizontal Storage Module and transfer in the NUHOMS® OS197H transfer cask, with a maximum heat load of 24 kilowatts.

The staff also proposes that changes be made to the rule text to correct a typographical error that incorrectly states the expiration date of the CoC. The correct expiration date, as listed in CoC No. 1029 for the Standardized Advanced NUHOMS® System, is February 5, 2023.
