On February 3, 2005, members of the U. S. Nuclear Regulatory Commission (NRC) staff met with Indiana Michigan Power Company (IM, the licensee), representatives at NRC Headquarters, One White Flint North, 11555 Rockville Pike, Rockville, MD. The meeting was a Category 1 public meeting.

The purpose of the meeting was to allow the licensee to discuss its plans to upgrade the nuclear fuel at Donald C. Cook Nuclear Plant, Unit 1, and the associated 10 CFR 50.46 loss-of-coolant accident reanalysis schedule, which is applicable to both units (refer to licensee letter ML050040216, dated December 28, 2004), and to obtain feedback from the staff. The NRC staff provided comments during the licensee's presentation and expressed reservations with the licensee's proposed mixing of the WCOBRA/TRAC evaluation model with the BASH evaluation model. The licensee expressed appreciation for the staff's feedback. The licensee is still relatively early in their evaluation process. The licensee plans to evaluate the staff's comments for applicability to their analysis and anticipates further discussions with the staff before making a licensing application. No regulatory decisions were made at the meeting.
