Federal oversight of radiological emergency planning and preparedness associated with commercial nuclear facilities involves both the Federal Emergency Management Agency (FEMA) and the NRC. Consistent with President Carter's directive in December 1979 and the longstanding Memorandum of Understanding between FEMA and the NRC, FEMA takes the lead in reviewing and assessing offsite planning and response and in assisting State and local governments, while NRC reviews and assesses the onsite planning and response. Using FEMA's input, NRC then makes a determination on the overall state of emergency preparedness.
