Dear Ms. Schick:

We have reviewed the letter dated January 31, 2005, to meet the financial assurance requirements for your license. We have no further questions at this time.

The following documents currently provide your financial assurance for decommissioning:

Certification of Financial Assurance dated October 17, 1991; Letter of Credit dated December 14, 2004; and Standby Trust Agreement dated November 24, 2004, with attachments.

In addition, we are returning the original of the Escrow Agreement dated October 5, 1998, Letter of Credit dated October 16, 1991, with an amendment dated October 19, 1998 and Letter of Credit dated October 18, 1990. These documents have been superceded by the documents identified above.

Please ensure that this accounting is accurate and that any changes to the documents which provide financial assurance for decommissioning are submitted and reviewed by the NRC as required.

As previously stated, the requirements for financial assurance are going to change effective June 2, 2005. Specifically, the financial assurance for decommissioning, required for licensee's which are authorized to possess NRC licensed materials in amounts greater than 10³ but less than 10⁴ times the applicable quantities of Appendix B to 10CFR Part 30, in unsealed form, as further defined in 10 CFR 30.35 (d), will increase from \$150,000 to \$225,000. If you have not reduced your possession limits prior to this date, you must have this amount in place on June 2, 2005, using one of the acceptable methods defined in 10 CFR 30.35 (f).
