Dear Administrative Judges:

This is to inform you that additional material has been restored to the public Citrix-based version of the ADAMS Publicly Available Records System ("PARS"). The restored version of PARS includes the docketed material related to the three pending applications for early site permits ("ESPs") under 10 C.F.R. Part 52. Specifically, documents contained in the Grand Gulf ESP docket, 52-009, are now available through the Citrix-based version of PARS.
