Dear Mr. Rahimi:

Washington TRU Solutions LLC, on behalf of the U.S. Department of Energy (DOE), hereby requests a revision to the Certificate of Compliance (CoC) for the TRUPACT-II Packaging, U.S. Nuclear Regulatory Commission (NRC) Docket No. 71-9218. This application is being submitted for review after the previously submitted Revision 21 of the application for a CoC for the TRUPACT-II packaging and Revision 4 to the application for a CoC for the HalfPACT packaging (NRC Docket No. 71-9279). It is requested that the previously submitted application for Revision 21 of the TRUPACT-II packaging and Revision 4 of the HalfPACT packaging continue to be given priority over this submittal.

By this application, DOE is requesting an exemption from Title 10, Code of Federal Regulations (CFR), Section 71.43(d), for shipments of the ARROW-PAK™ payload container in the TRUPACT-II packaging. The enclosed document, TRUPACT-II SAR Addendum for ARROW-PAK, provides complete documentation of the safety analysis and testing performed on the ARROW-PAK payload container and includes a description of the authorized contents. Section 10.5 of the TRUPACT-II SAR Addendum for ARROW-PAK provides the justification for the request for an exemption from 10 CFR 71§71.43(d).

Upon NRC approval of this application, it is requested that the CoC for the TRUPACT-II be revised to include a statement similar to the following:

"Shipment of the ARROW-PAK payload container in the TRUPACT-II shall meet the specifications and conditions of the TRUPACT-II SAR Addendum for ARROW-PAK."


