Dear Mr. Peterson:

This is in reference to your application dated December 20, 2004 requesting to renew Nuclear Regulatory Commission License No. SNM-296. In order to continue our review, we need the following additional information:

1. We reserve the right to request a complete, up-to-date application. The licensing guidance and regulations have changed since this license was last renewed in 1994. We have reviewed your submission and existing license and request that you submit a single, complete renewal application using the enclosed guide, NUREG-1556, Volume 17, "Consolidated Guidance About Materials Licenses Program-Specific Guidance About Special Nuclear Material of Less Than Critical Mass Licenses" published November 2000. Section 8 "Contents of an Application" and Appendix C should be helpful with drafting your renewal application.
2. You have submitted your Radiation Safety Manual as part of your license application. Please note that by including your manual, any changes in the manual information and procedures must be submitted to the NRC and approved by amendment of your license prior to implementing the changes. If the application follows the format in NUREG-1556, Vol. 17, Appendix C and includes all the requested information, it will not be necessary to include your manual as part of the application. Please consider not including your manual with your re-submitted renewal application.

In accordance with 10 CFR 2.390, a copy of this letter will be placed in the NRC Public Document Room and will be accessible from the NRC Web site at <http://www.nrc.gov/reading-rm.html>.

We will continue our review upon receipt of this information. Please reply to my attention at the Region I Office and refer to Mail Control No. 136178. If you have any technical questions regarding this deficiency letter, please call John Nicholson at (610) 337-5236.
