SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE

Dear Mr. Harmon:

By letters dated March 12, 1999, and May 14, 1999, you submitted to the NRC responses to our requests for information. These responses contained Safety Light Corporation income tax information and other corporate financial information. Your letters and affidavits requested that this information be withheld because it contains confidential financial information.

We have reviewed your request based on the requirements and criteria of 10 CFR 2.790 and have determined that the information sought to be withheld contains confidential financial information. Therefore, the information which you have identified will be withheld from public disclosure pursuant to 10 CFR 2.790(a)(4) and Section 103(b) of the Atomic Energy Act of 1954 as amended.

If the basis for withholding this information from public inspection should change in the future, such that the information could then be made available for public inspection, you should promptly notify the NRC. You should also understand that the NRC may have cause to review this determination in the future, such as, if the scope of a Freedom of Information Act request includes your information. If the NRC determines that the information should be made publicly available as a result of a future review, you will be notified in advance of any public disclosure.
