c. Dr. John R. Frazier

SLC has not determined which persons it will rely upon as witnesses. SLC does not have any analyses or other authority upon which the above persons base their respective opinions. Dr. Frazier was formerly employed by Auxier & Associates, Inc. in Knoxville, Tennessee. SLC has attempted to contact Dr. Frazier but has been unable to reach him. SLC will provide his address and phone number in an updated disclosure when this information is available.

2. Category and location of relevant documents and data compilations in the possession, custody, or control of SLC.

SLC possesses the following categories of documents and data compilations that may be relevant to the hearing issues, and, upon request, will make them available for review at its site in Bloomsburg, PA:

- a) Records of payments into and withdrawals from the escrow account maintained for decommissioning (certain of these records also are publicly available on the NRC's ADAMS system. Examples of such records include monthly reports of the escrow account trustee (see ADAMS nos. ML043230536, ML042940171, ML042530598, ML042320539, ML042080526, ML041890426, ML04130519, ML041110823, ML040810072, ML040580436, ML040580430));
- b) Correspondence with the NRC, including the results of NRC inspections and investigations (many of these documents are available in ADAMS, and can be found by using the "find" tool to search under docket numbers 03005980 and 03005982);
- c) Records of financial transactions, including accounts payable information (i.e., accounting general ledger for accounts payable, vendor check registers and historical aged trial balances), receipts, sales shipments and deliveries, payroll, taxes, etc. (As discussed further below, many of these records contain confidential commercial information or personnel information, the disclosure of which would constitute a clearly unwarranted invasion of privacy);
- d) Records maintained to meet NRC requirements, including records of surveys, tests, audits, inspections, releases, personnel doses, etc.;

- e) Records related to site remediation activities, including decommissioning plans and cost estimates;
- f) Records related to radioactive waste from ongoing operations, including records related to returned devices and their disposition, inventory of waste, and cost estimates for the disposal; and
- g) Records related to internal SLC communications concerning the operation of the plant.

As indicated in paragraph 2, some of these documents are publicly available. With respect to the balance of the documents, SLC will provide you with a copy of individual documents upon request.

- 3. Category and location, of tangible things (e.g., books, publications and treatises) in the possession, custody or control of SLC that are relevant: SLC has not identified any tangible things that are potentially evidence that is relevant to the hearing issues.
- 4. Documents otherwise required to be disclosed for which a claim of privilege or protected status is being made. Certain business records contain confidential commercial information related to the identification of specific customers and the terms of commercial agreements. SLC has not compiled a list of such documents since it does not expect that any party will seek to make such information available to the public. SLC does not object to disclosing such information to the parties, upon request, subject to suitable agreement not to disclose such information to the public.

Certain records contain personnel, medical, and similar records related to individuals, such as SLC employees. Such records include information such as social security numbers, home addresses, telephone numbers, salaries, exposures to radiation, etc. SLC does not object to disclosure of such information to the parties, to the extent permitted by law, subject to suitable agreement not to disclose such information to the public.

A list of privileged documents is attached.

In order to compile these attachments, SLC made a reasonable search of its files. SLC is attaching an affidavit which attests that all relevant materials identified by this search have been disclosed, and that the disclosures are accurate and complete as of the date of the affidavit.
