SUBJECT: DISCUSSION OF SECURITY ASSESSMENT

Dear Dr. Singh:

In accordance with the Atomic Energy Act of 1954, as amended, and 10 CFR Part 72, Holtec International (Holtec or the vendor) holds Certificate of Compliance No. 1008 for the Model No. HI-STORM 100 Cask System. In a phone call on January 27, 2005, Holtec agreed to meet with the U.S. Nuclear Regulatory Commission (NRC) staff with safeguards security measures in place. The purpose of the meeting(s) is to discuss the NRC's engineering evaluations performed to evaluate the safety and security of an array of HI-STORM storage casks. The meeting(s) will be closed to the public.

To facilitate your participation in the upcoming meeting(s), the NRC must authorize the appropriate personnel at your company to receive the information, which the NRC will designate as Safeguards Information under Section 147 of the Atomic Energy Act of 1954, as amended (Enclosure 1). Each licensee who receives Safeguards Information must protect it from disclosure to unauthorized individuals.

Enclosed are NUREG-0794, "Protection of Unclassified Safeguards Information," (Enclosure 2) and Regulatory Issues Summary 2003-08, "Protection of Safeguards Information from Unauthorized Disclosure," (Enclosure 3), which describes what you must do to protect Safeguards Information. Please respond no later than 7 days from the date of this letter, with the names of no more than four individuals who will be initially granted NRC authorization to view, discuss, and receive Safeguards Information. These individuals must have a "need to know" the information and be trustworthy and reliable. Not everyone who may in the future have a need to access Safeguards Information needs to be authorized at this time. There will be a process to allow you to authorize other individuals to have access to Safeguards Information. At this time, the NRC needs to authorize a few key individuals, who will be responsible for evaluating the engineering and consequence calculations performed for your storage casks, to access Safeguards Information.

Please provide the following information:

1. full name and country of citizenship of each individual to be granted initial access authorization for Safeguards Information,
2. position or title,
3. your basis for determining each individual listed has an established need-to-know,

4. your basis for determining each individual to be reliable and trustworthy, and
5. an affirmation that you have the appropriate capability, as described in Enclosure 2, to protect Safeguards Information.

The determination in number 3 above should be based upon the nature of the individual's position and duties. The determination in number 4 above should be based upon the length of an individual's employment and other pertinent factors you have considered.

Based on your response, we will send you a letter that grants your designated personnel initial authorization access to Safeguards Information and forwards the draft additional security measures and implementing guidance for you to review. At the same time we will issue an Order that will require you to protect Safeguards Information in accordance with Enclosure 2. Only individuals that have been authorized access to Safeguards Information will be authorized to attend the meeting.
