Dear Mr. and Mrs. Baird:

On November 26, 2004, the U.S. Nuclear Regulatory Commission (NRC) sent you a letter requesting information in order to complete our assessment and to determine the future steps to address remediation at the former Salmon River Uranium Development, Inc. (SRUD) mill site located near North Fork, Idaho. In the November 26, 2004, letter, we requested that you provide the information within 30 days from the date you received the letter. The NRC Project Manager, Rafael L. Rodriguez, has not received any written or oral response from you regarding our request. Mr. Rodriguez has tried to reach you several times at the phone number that you provided to us earlier, but has been unsuccessful in these efforts. As the current owner of the former SRUD site, which is subject to NRC jurisdiction, it is necessary that you respond to our request for information.

Please provide the following information within 30 days from the date you receive this second letter:

- a) Your future plans for the property;
- b) Confirmation about whether your current financial situation has changed since 2003, i.e., your July 7, 2003, letter to Mr. Bob Evans stated that you did not have the resources to remediate the property; and
- c) Confirmation of the number of jugs containing liquid thorium product that was produced at the SRUD site and the location of these containers.

As the current owner of the SRUD site, you have the primary responsibility to remediate the site and to ensure that the property meets the radiological criteria requirements in 10 CFR Part 20, Subpart E of NRC regulations. Please be aware that this is our final attempt to resolve this matter informally. If we do not receive any communication from you within the specified timeframe, the NRC will pursue a more formal approach. This could include the issuance of an Order placing the site under an NRC license. As an NRC licensee, non-adherence to NRC regulations could subject you to civil and criminal sanctions.

As a reminder, you must refrain from beginning decommissioning or disposing of radioactive waste without prior NRC notification and approval.
