Yawar:

An envelope containing the partial application was in the mailbox when I got home from work tonight.

The attorneys and other resources that had been recommended to me for work with on the petition to intervene, had a response was similar to mine - that the remaining two weeks is humanly impossible to prepare a petition, and the full application has not been made available.

After multiple requests, I have not received a transcript from the November 8 USEC/NRC compliance meeting, either. Dave Hartland sent a video game link, and the e-mail that I received later from you consisted of a meeting agenda outline (with portions blacked out) and some accompanying charts with inadequate information to interpret them. My computer time is limited. I tried to access information on the NRC website specific to Piketon multiple times, but the documents would not open.

It was my understanding that this information should be available to the public for comment for the EIS and petitions to intervene as it is our only access to USEC's most recent safety and violations history, and the meeting was supposed to be public.

I would like to know if there is someone on the commission that I can submit a request to for a reasonable extension of time to prepare a petition to intervene. Under NEPA there is supposed to be opportunity for meaningful

public input, and I do not believe the NRC provided critical information, central to the process, in a way that permits this.

Subject: USEC's application

After the scoping meeting at Piketon, I asked one of the co-presenters, Jennifer Davis, what could be done to receive a full copy of USEC's application. The original was 1000+ pages, and the censored version made available to the public three weeks before the meeting was approximately two-thirds less - 350 pages.

She said that if we were filing a petition to intervene that we were eligible to receive a complete hard copy of USEC'S application. I was one of six parties who requested and was granted an extension of time to file a petition to intervene, and I would like to have a copy of the full application mailed (allowing adequate time to review and submit my petition prior to the deadline) to:

It is my understanding that basic health and safety information, including occupational, transportation and worst-case accident scenarios were similarly removed by the NRC from LES's application before giving community members in New Mexico two weeks to submit their comments. I believe this information is vitally necessary in order to comment on the placement of such a facility Ohio.
