I would appreciate it very much if you each would reply to me quickly with your opinion as to whether or not I will be mailed this information to the address below, and how soon I might receive it?

We have been told by NRC that those requesting an extension of the time for filing a Petition to Intervene would be eligible to receive a complete hard copy of USEC'S application. The Sierra Club was one of six parties who requested an extension, and we would like to have a copy of the full application. We need adequate time to review and submit my petition prior to the deadline, which is approaching soon.

The original USEC application was 1000+ pages, and the censored version made available to the public three weeks before the scoping meeting was approximately two-thirds less - 350 pages.
