The checklist in Appendix B in NUREG-1556, Volume 1, Revision 1 contains procedures that are acceptable to the NRC and may be used to submit your response. Please photocopy Appendices A and B, checkmark the appropriate boxes and submit.

Please note that on October 25, 2004, the NRC suspended public access to ADAMS, and initiated an additional security review of publicly available documents to ensure that potentially sensitive information is removed from the ADAMS database accessible through the NRC's web site.
