

Pursuant to telephone instructions received from Willie Lee of your office, the purpose of this letter is to provide notice to the US Nuclear Regulatory Commission ("NRC") of a transaction affecting the above facility. We also are asking for written confirmation of how NRC will treat this transaction, and of the applicable procedures.

This office represents Bon Secours New Jersey Health System, Inc. ("BSNJHS"), a New Jersey non-profit corporation, and Canterbury Health Services, Inc. ("CHS"), a New Jersey non profit corporation, in connection with certain licensure and permitting aspects of a transaction scheduled to close on December 31, 2004 between BSNJHS and CHS arising from the court-approved settlement of litigation encaptioned Canterbury Health Services, Inc. v. Bon Secours New Jersey Health Systems, Inc., et al.


Christ Hospital, a New Jersey nonprofit corporation ("Christ") is, as its name suggests, a non-profit corporation. As a non-profit corporation, it has members, rather than shareholders. Until the closing of the transaction on December 31, 2004, the sole member of Christ is and will be another non-profit corporation, Bon Secours and Canterbury Partnership for Care, Inc. ("BSCPC"). The members of BSCPC are BSNJHS and CHS.

Pursuant to the settlement agreement, BSCPC will be dissolved on December 31, 2004. CHS will become the sole member of Christ. There will be no purchase of assets. It is anticipated that Christ's current management will remain in place after the transaction closes. Christ will retain its current name. Two charts showing the corporate structure before and after the December 31, 2004 closing are enclosed.

There has been no change in management at Christ, the Radiation Safety Officer remains the same, and the radiation safety program remains the same. Accordingly, we have been advised by Willie Lee of your office that relicensure of Christ will not be required. We respectfully request your written confirmation that our understanding is correct. We will provide you with a letter confirming when the transaction has been completed.

If you require any additional information regarding this matter, please contact me. Thank you for your assistance and consideration. In light of the planned closing of this transaction on December 31, 2004, we particularly appreciate your attention at this busy time of year.


