SUMMARY

By application dated January 28, 2005, Columbiana Hi Tech, LLC, requested that Certificate of Compliance No. 9284, for the Model No. ESP-30X package, be revised to reflect the correct certificate holder name and address. On January 1, 2005, the operations of Columbiana Hi Tech Front End, LLC, was merged into the operations of Columbiana Hi Tech Spent Fuel, LLC. The combined entity now operates as Columbiana Hi Tech, LLC. Columbiana Hi Tech, LLC, did not request any changes to the package design or authorized contents.

EVALUATION

By letter dated January 28, 2005, Columbiana Hi Tech, LLC, requested a revision to Certificate of Compliance No. 9284 for the Model No. ESP-30X package. Columbiana High Tech did not request any changes to the package design or authorized contents.

The following changes have been made to the certificate:

In response to this letter, Condition No. 3.a has been changed from Columbiana Hi Tech Front End, LLC, to Columbiana Hi Tech, LLC. The address has also been updated.

Condition No. 5.(c) of the certificate was revised to replace the wording "Transport Index for Criticality Control" with "Criticality Safety Index" as defined in 10 CFR 71.4.

Condition No. 10 of the certificate was revised to clarify that the package is approved for use under the general license provisions of 10 CFR 71.17. This change is due to a revision in the numbering of the sections in 10 CFR Part 71, that became effective on October 1, 2004 (69 FR 3698).

CONCLUSION

These changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.
