# REQUESTS FOR ADDITIONAL INFORMATION ON PROPOSED SECTION 6.7 KERR-MCGEE CUSHING (KMG) SITE DECOMMISSIONING PLAN (DP)

# 1) Paragraph 1; Sentence 2

Describe the methods or practices (e.g., pre-planning coordination meetings, notifications) that will be implemented to "keep these activities to a minimum" that could potentially impact areas which have a completed Final Status Survey (FSS), but which have not yet been released from the license.

## 2) Paragraph 4; Sentence 2

Describe the "appropriate surveys and sampling of excavated material and the excavations" that will be performed (or reference/identify previous sections of the DP, as appropriate).

## 3) Paragraph 5; Sentence 1

Describe the "data package" that will be prepared where disturbance occurs after the FSS (or reference/identify previous sections of the DP, as appropriate).

#### 4) Paragraph 5; Last sentence

Briefly describe how "material exceeding the decommissioning criteria or adversely affecting . . the FSSR," will be managed if it is discovered. (Reference/identify previous sections of the DP, as appropriate).

#### 5) Table 1

Several activities in Table 1 involve heavy equipment and truck or vehicle traffic as part of the description of how the impacted sectors could be affected. Excavations and excavated soil will be surveyed and sampled, as described in paragraph 4 of Section 6.7, but there is no mention of plans for surveying/sampling of roads and/or areas that may have significant truck or vehicle traffic. Briefly describe the circumstances under which KMG will survey/sample non-excavation-related areas of the impacted sectors, and what methodologies will be used.
