The U.S. Nuclear Regulatory Commission (NRC) has issued the enclosed Order requiring you to implement specific requirements to ensure proper handling and protection of safeguards information (SGI) to avoid unauthorized disclosure. The Order contains requirements that Part 71 Certificate of Compliance holders must implement beyond those currently required by NRC. You must respond to this Order by filing a written answer under oath or affirmation, consenting to the Order or providing the reasons why you believe the Order should not have been issued. The NRC has taken this action because it intends to meet with you and representatives of NAC International, Inc., to discuss the engineering evaluations that the NRC has performed on the NLI 1/2 and NAC-UMS transportation packages for our security assessments.

Under Section 147 of the Atomic Energy Act of 1954, as amended, the Commission has authority to "issue such orders, as necessary to prohibit the unauthorized disclosure of safeguards information...". Unauthorized disclosure of SGI may result in civil and criminal penalties.
