## Dear Sir/Madam:

This letter is to inform you that my staff is completing an Environmental Assessment (EA) for the proposed amendment of Source Materials License No. SUA-1350, issued to the Kennecott Uranium Company (KUC) for the Sweetwater Uranium Project near Rawlins, Wyoming. By letter dated May 12, 2004, KUC requested that the U.S. Nuclear Regulatory Commission (NRC) approve a proposed catchment basin remediation plan. This plan addresses soil and ground water contamination caused by the subsurface release of process fluids from the basin. The plan, modified by submittals dated July 22 and December 15, 2004, includes a change to the Corrective Action Plan for ground water, the environmental monitoring program, and the surface reclamation plan.
