#### Chairman Diaz' Comments on SECY-05-0029

I approve the staff's recommendations, in SECY 05-0029, to simplify the title of the NRC's Enforcement Policy from "General Statement of Policy and Procedures for NRC Enforcement Actions - Enforcement Policy," to "NRC Enforcement Policy," and to discontinue publishing the policy, in paper form, as NUREG-1600. Posting the Enforcement Policy on the NRC's public Web site to achieve widespread dissemination is a more effective and efficient approach than the occasional publication of the Enforcement Policy as a NUREG. The staff should continue to make the policy available in ADAMS and publish revisions in the Federal Register.

I approve the staff's recommendation to publish the Federal Register notice for announcing the above changes subject to the attached edits.

SUMMARY: The Nuclear Regulatory Commission (NRC) is announcing its intent to use the and the NRC's Agricultural Document Access and Management System NRC public Web site to communicate its "General Statement of Policy and Procedure for NRC CADAMS) Enforcement Actions - Enforcement Policy," to discontinue publication of the paper document, NUREG-1600, and to simplify the official policy statement title. The NRC is taking these actions because the policy statement is available electronically on the NRC public Web site and is widely known as the "NRC Enforcement Policy."

#### SUPPLEMENTARY INFORMATION:

The Commission first published its "General Statement of Policy and Procedure for NRC Enforcement Actions - Enforcement Policy," (Enforcement Policy) on October 7, 1980 (45 FR 66754). The Policy was codified as Appendix C to Part 2 of Title 10 of the Code of Federal Regulations to provide widespread dissemination. However, the Enforcement Policy has always included a statement recognizing that it is a policy statement and not a regulation. An underlying basis of the Enforcement Policy reflected throughout it is that the determination of the appropriate sanction requires the exercise of discretion such that each action is tailored to the particular factual situation.

On June 30, 1995, the NRC announced that it was removing the Enforcement Policy from the Code of Federal Regulations (CFR) (60 FR 34380). This action was part of an enforcement program review, to avoid any interpretation that the policy should be construed as a regulation. To continue to ensure widespread dissemination, the NRC published the Enforcement Policy in its NUREG-series publications as NUREG-1600 and continued to publish revisions to the Enforcement Policy in the *Federal Register*. NUREG-1600 was first published in July of 1995. The last complete revision that was issued as a NUREG-series publication

(NUREG-1600) was dated May 1, 2000. However, the Enforcement Policy has been revised on multiple occasions (as published in the *Federal Register*) without being republished as a NUREG document.

The NRC maintains the current Enforcement Policy on its Web site at <a href="http://www.nrc.gov">http://www.nrc.gov</a>, select What We Do, Enforcement, then Enforcement Policy. The Enforcement Web site also includes a history of the Enforcement Policy by including and/or referencing the Federal Register notice for each policy revision since it was first published in 1980.

#### Commissioner Jaczko's Comments on SECY-05-0029

I approve of the staff's recommendation to publish a *Federal Register* notice announcing the NRC's intent to discontinue publication of NUREG-1600 in paper form and simplifying the title of the policy to "NRC Enforcement Policy." I believe that continuing to publish revisions to the Enforcement Policy in the *Federal Register*, and providing printed copies to licensees and individuals being considered for significant enforcement action who may not have easy access to the web, will ensure the NRC's commitment to openness while also increasing efficiency. The Staff should, additionally, be prepared to provide printed versions of the enforcement policy upon request to any interested stakeholder.

I also approve the *Federal Register* notice prepared by the staff, subject to attached edits, and concur with Commissioner Lyons' comment that if negative public comments are received on this notice, the staff should, again, consult with the Commission.

### Commissioner Lyons' Comments on SECY-05-0029

I approve the staff's recommendation to publish a *Federal Register* notice announcing the NRC's intent to discontinue publication of NUREG-1600, "General Statement of Policy and Procedure for NRC Enforcement Actions - Enforcement Policy," and to use the NRC Web site for dissemination of the enforcement policy. The purpose of publishing the enforcement policy as a NUREG was to make the enforcement policy easier to identify and locate. Since the NRC Web site provides widespread communication of the enforcement policy, publication and dissemination of hard copies of the enforcement policy seems unnecessary.

In addition, I approve the *Federal Register* notice prepared by the staff. I also agree that the enforcement policy should be renamed, "NRC Enforcement Policy."

If public comments are received in opposition to the proposal, the staff should consult with the Commission again on this matter.
