Dear Mr. Smith,

On October 3, 2003, the Commission issued amended rules for financial assurance for decommissioning applicable to NRC licenses issued pursuant to 10 CFR Parts 30, 40, and 70 (68 FR 57327). The rules became effective on December 2, 2003; however, existing licensees are permitted to implement the rules over a period of time. The implementation schedule is shown below:

Using a DFP	Revise cost estimate and cover new amount every 3 years	December 4, 2006 (unless licensee committed to earlier date in DFP)		

This letter simply brings the implementation schedule to your attention. No response to this letter is required. However, if you are among those licensees whose financial assurance has been increased from \$750K to \$1,125K and you have not taken steps to do so, you are required to revise your financial assurance instruments promptly.
