SUMMARY

By application dated January 13, 2005, the Department of Energy, Division of Naval Reactors, requested an amendment to Certificate of Compliance No. 6386, for the Model No. 235R001 package. The Division of Naval Reactors requested that Certificate of Compliance No. 6386 be renewed. Based on the statements and representations in the application, as supplemented, the staff agrees that the changes are only administrative and do not affect the ability of the package to meet the requirements of 10 CFR Part 71.

EVALUATION

The Department of Energy, Division of Naval Reactors, requested renewal of Certificate of Compliance No. 6386, for the Model No. 235R001 package. The Division of Naval Reactors did not request any changes to the package design or authorized contents. The Division of Naval Reactors stated that there has been no operational experience or container modification that would preclude future use of this package.

The following changes have been made to the certificate:

Condition No. 5(c) of the certificate was revised to replace the wording "Transport Index for Criticality Control" with "Criticality Safety Index" as defined in 10 CFR 71.4.

CONCLUSION

The certificate has been renewed for a five year term that expires on April 30, 2010. These changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.
