SUBJECT: CONSTRUCTION AUTHORIZATION AND FINAL SAFETY EVALUATION REPORT FOR CONSTRUCTION OF THE MIXED OXIDE FUEL FABRICATION FACILITY

Dear Mr. Barnes:

The U.S. Nuclear Regulatory Commission (NRC) is issuing Construction Authorization No. CAMOX-001 (Enclosure 1) to Duke Cogema Stone & Webster, on the basis of our review of your construction authorization request dated October 31, 2002 (as subsequently revised). Construction Authorization No. CAMOX-001 (CA) expires at midnight, March 30, 2015.

The technical basis for issuing the CA is set forth in NUREG-1821, "Final Safety Evaluation Report on the Construction Authorization Request for the Mixed Oxide Fuel Fabrication Facility at the Savannah River Site, South Carolina" (FSER) (Enclosure 2). The FSER is being issued concurrently with the CA, but in redacted form. On October 25, 2004, the NRC had suspended public access to the ADAMS online library and some other parts of its Web site to review documents and remove any that could reasonably be expected to aid a potential terrorist. Related to this effort, the NRC is withholding some portions of the FSER which are deemed to contain sensitive information under 10 CFR 2.390.

The results of the environmental review related to the issuance of the CA are contained in NUREG-1767, "Final Environmental Impact Statement on the Construction and Operation of a Proposed Mixed Oxide Fuel Fabrication Facility at the Savannah River Site, South Carolina" (ADAMS Accession Nos. ML050240233 and ML050240250), a redacted copy of which was published in January 2005.

Enclosure 3 is a copy of the *Federal Register* notice announcing issuance of the CA. The original notice has been sent to the Office of the Federal Register for publication.
