The purpose of this modification is to:

- (1) accept L-3 Communications Government Services Inc.'s proposal dated November 23, 2004, which is hereby incorporated by reference and made a part hereof this modification, to provide for an update to the NRC's standard desktop computing system from the Dell Model GX270 to the Dell Model GX280, as approved by Robert B. Webber, NRC Contracting Officer, via e-mail on November 24, 2004;
- (2) revise the labor hour requirements for Schedule A-1 Year 4 (OPTION) to reflect an increase in the hourly rate for the position of Senior Security Analyst from \$148.00 to \$153.92; and
- (3) revise the total estimated cost of Schedule A-1 Year 4 (OPTION) by \$11,366.40 from \$9,338,820.40 to \$9,350,186.80 and revise the total estimated cost (ceiling) of the task order by \$11,366.40 from \$37,776,984.42 to \$37,788,350.82, as a result of the increase in the hourly rate for the Senior Security Analyst.

Accordingly, the following changes are hereby made:

- (1) The task order is hereby modified to incorporate the Dell Model GX280 as the NRC's standard desktop computing system which shall be provided in accordance with the specifications reflected at Attachment 1 to this modification.
- (2) Under Contract Line Item Number 0004, Schedule A-1 Year 4 (OPTION) is hereby modified to increase the hourly rate for the position of Senior Security Analyst which shall be effective on November 20, 2004. Refer to Attachment 2 to this modification for a revised Schedule A-1 Year 4 (OPTION).
- (3) Under Paragraph B.8 - CONSIDERATION AND OBLIGATION, Paragraph (a) is hereby deleted in its entirety and substituted in lieu thereof the following:

 "(a) The total estimated amount of this contract (ceiling) for the products/services ordered, delivered, and accepted under this contract is \$37,788,350.82."
