## **SYNOPSIS**

This investigation was initiated on January 12, 2004, by the U.S. Nuclear Regulatory Commission, Office of Investigations, Region III, to determine if a Security Officer at the Perry Nuclear Power Plant (Perry) was discriminated against for raising safety concerns.

Based on the evidence developed, this investigation did not substantiate the allegation that a Security Officer at Perry was discriminated against for raising safety concerns.
