The purpose of this modification is to provide incremental funding in the amount of \$200,000. Accordingly, the following change is made:

Section A.2 Consideration and Obligation, paragraph (B), the obligated amount is increased by \$200,000 from \$300,000 to \$500,000. Therefore, the first sentence of subparagraph (b) is revised to read as follows:

“(B) The amount presently obligated with respect to this order is \$500,000.”
