This is in reference to your application dated March 13, 1991 for a byproduct material license. In order to continue our review, we need the following additional information:

- In your response to question 4 of our June 3, 1991 letter, you gave exposure data. Please specify if this data is from the manufacturers' of your gauges, if it is worse case data, at what distance from the radiation source it represents, the closest distance hands will be from the radiation source during the window change and an estimate of the beta exposure to the hands.
- 2. Please note that the presence or absence of a green indicator light would not be sufficient by itself to assure the gauge shutters are closed prior to performing maintenance on gauges. Please describe another means by which you can assure the source is fully shielded prior to beginning work, f.ex, as described in Mr. Prendergast's window change procedure, in addition to a green light indicator, a viewing port is checked to assure shutter closure prior to a window change.
- 3. You should provide the following information on the "responsible individual's" training.
 - The time spent on each topic a)
 - How the person or firm giving the trainingcourse determined the competency b) of individuals to perform the services.

We will continue our review upon receipt of this information. Please reply in duplicate to my attention at the Region I office and refer to Mail Control No. 114425.
